Members as well as dependent children or grandchildren of Sudbury Credit Union members, excluding employees and Board members that are entering their 1st Year of post-secondary education.

General Rules

1. The member must complete and sign the Bursary Application Form.
2. The applicant must be entering the first year of full-time post-secondary education at an eligible institution and must provide a Letter of Acceptance.
3. Only one application per member is permitted. It must be received at Sudbury Credit Union by 4:00 p.m. on August 1, 2019. The random draw will be made at the Sudbury Credit Union office, supervised by the CEO or a designate, on August 6, 2019.
4. Each draw will be for \$500.00. Winners will have the amount deposited into a Sudbury Credit Union account in the same name of the winning member.
5. Winners will be contacted and must agree to have their name published in Sudbury Credit Union publications and/or on the Sudbury Credit Union website.
6. In the event that a winner is unable to attend an eligible institution the payment will be cancelled and the money shall remain the property of the Sudbury Credit Union Limited.
